#### Poor data management system led to multiple challenges

- The company did not have any centralized data and reporting system in place.
- Due to fragmented data, teams had to perform all reporting manually. This was time-consuming and prone to human errors.
- Manual reports were siloed and spread across excel sheets floating across different systems and locations. Reporting formats too were inconsistent across locations.
- There was no way to leverage unique data cuts required for leadership decision-making, and for varying hierarchies and locations. For example, the leadership team had to look at different reports for "top contributing partners" or "top contributing locations" and unable to drill down.
- It was a challenge to restrict role-based access to the reports.
- Skill mapping for cases for severely restricted due to manual reporting, and it was challenging to find subject matter experts quickly and seamlessly.

#### Unlocking enhanced decision-making abilities with Power BI

Acuvate integrated the siloed databases and extracted the data through automated ETL jobs. We then created Self Service Power BI reports enabling real-time reporting and information access.

The enhanced reporting system enabled the law firm leaders to slice and dice insights by various attributes like location and office, clients, partner etc. Such in-depth insights into finances and operations enabled the law firm to quickly and seamlessly identify top revenue clients, top performing offices and partners, and make the right decisions at the right time.

Empowered with role-based security, the new reporting dashboards was easily accessible by authorized personnel at any time.

With mobile enabled dashboards and NLP capabilities, the law firm's leaders could ask relevant natural language questions like "Who are the top 5 clients in Real Estate Industry" and get insights at anytime, anywhere and on any device. This enabled better and faster business decision-making.
